How to make a bequest to Calgary’s Prostate Cancer Centre

Decide: What program or service you want to support; include the type of bequest you would like to make to Calgary’s Prostate Cancer Centre.

Complete: A declaration of intent form and send to Calgary’s Prostate Cancer Centre. The declaration of intent is not a legal or binding document, but it lets Calgary’s Prostate Cancer Centre know of your intentions to make a future gift.

Make: An appointment with your attorney or estate planner to discuss your options. When you draft or update your will, address your plans to make a bequest to Calgary’s Prostate Cancer Centre.

Contact: Us to discuss your gift and provide a copy of the relevant provision from your will benefiting Calgary’s Prostate Cancer Centre.

Wills can be complex documents and should be drafted with the assistance of legal counsel. The wording of a bequest, if not crafted properly, can become difficult to administer. To ensure correct and timeless wording that best honours your true intention, we would be happy to help you and your advisor fine-tune the relevant clause in your will.

Wills & Bequests



A bequest in your will is a simple way to make a gift to Calgary’s Prostate Cancer Centre. By leaving a bequest, you are helping to ensure that men in your community will continue to receive support, early diagnosis, treatment, and education about prostate cancer.

Once you have provided for your family and loved ones, you may want to consider naming Calgary’s Prostate Cancer Centre as a beneficiary of a portion of your estate.

Benefits of Leaving a Bequest to Calgary’s Prostate Cancer Centre

A bequest is a commitment to support Calgary’s Prostate Cancer Centre beyond your lifetime.

A bequest provides you with the opportunity to make a significant gift without it affecting your current financial situation.

Since bequests are considered charitable donations and are eligible for tax receipts, you would be able to reduce taxes on your estate.

With planning, a gift in your will doesn’t have to take away from what you leave your loved ones.

A bequest is revocable and you may change your mind at any time during your lifetime.

Types of Bequests

Specific Bequest: The donor indicates that the charity is to receive a specific piece of property, such as real estate, stocks, bonds, or art.

Residual Bequest: The donor gives the charity all, or a portion of, their estate after all the debts, taxes, expenses, and other bequests have been paid.

Contingent Bequest: This bequest takes effect only upon the occurrence of some other event. For example, in the event that others named in your will predecease you, you may choose to make a charity the contingent beneficiary.

Bequest Program Areas: Bequests can be “restricted,” meaning the donor specifies that the gift be used for a specific program or purpose. An “unrestricted” gift allows the charity to support needs of the highest priority.
